Pursuant to the company's Long Term Incentive Plan for Executives, 334,480 performance rights have vested and the company has issued fully paid shares. An Appendix 3B and a Director's Interests Notice are attached. 318,801 performance rights have lapsed.

The issue of shares to the company's USA executives causes a withholding tax obligation. Consistent with prior years, the Board is permitting USA executives to sell shares to cover the tax and associated brokerage.
