Fixed Photo Enforcement Camera Support and Maintenance Panel Contract (Detection and Enforcement Systems Agreement) with Roads & Maritime Services, New South Wales

Redflex Holdings Limited (**ASX:RDF**) (**Company**) today announces that the Company's subsidiary, Redflex Traffic Systems Pty Ltd, has entered into a non-exclusive three-year panel contract¹ with Roads & Maritime Services (**RMS**) under which RMS may issue orders for the support and maintenance of certain fixed photo detection and enforcement cameras throughout New South Wales, Australia.

During the term:

- If RMS issues an order, the Company's subsidiary will provide its specialized services to support and maintain these fixed photo enforcement cameras which may include fixed digital speed systems, red light and speed systems, bus priority lane enforcement systems, transit way enforcement systems, over-height and over-length detection, average speed and vehicle emissions enforcement systems; and
- RMS may also request Redflex to provide additional fixed photo enforcement camera system installations in areas within New South Wales which would then fall under the support and maintenance agreement.

It is anticipated that the support and maintenance work under this panel contract may generate revenue for the Company in the approximate range of AUD4.5 to AUD5.5 million per annum.

RMS is an agency within 'Transport for NSW' (part of the New South Wales State Government) with the responsibilities to deliver safe and efficient journeys throughout New South Wales and to manage the operations and programs of roads and waterways.

¹ There is the ability for this panel contract to be extended by the customer for two one-year options to renew.
